Spotlight On: Midland's Intern & Student Teaching Program

As a leader in special education for more than 60 years, The Midland School prides itself on being a community and academic resource in the field and staying at the forefront of industry trends, research, and teaching methods. One of the many ways Midland does this is through its Intern and Student Teaching Program.

"Midland is proud to partner with several colleges and universities to offer handson, practical experience," says Midland's School Principal, Ms. Kristen Massimo. "Students come to student teach and observe from Seton Hall, Rutgers, Kean, Centenary, TCNJ, NYU, Raritan Valley Community College (RVCC), Ithaca, Misericordia, and Bloomsburg."

In the Counseling Department, Midland has a long-standing relationship with Rutgers and works with their professors to identify qualified candidates that would benefit from the diversified experience Midland has to offer. Co-supervisors, School Psychologist, Dr. Tom Enos and Social Worker, Ms. Lily Riche both agree that the program is mutually beneficial to both the intern and Midland.

"While the interns start out shadowing sessions, it is not long before they jump into leadership roles and facilitate sessions independently," says Dr. Enos who currently has Rutgers Psychology undergrad, Jordyn Walsh interning for the spring semester.

"Establishing connections with the kids is the best part of being at Midland," says Jordyn, who plans to pursue her passion for special education and earn her master's degree. Within the related-services (speech, occupational and physical therapy), training interns gives Midland staff access to the most cutting-edge techniques and practices.

"I love having interns because they come with the newest information and their excitement and creativity provides a fresh prospective on things," says Speech Therapist, Ms. Cindy Migliore who describes the process as "I do. We do. You do."

Speech Therapist, Ms. Juliann Fischer concurs. Anita Fetic, a second-year master's student from Kean and current Midland intern, is already taking over planning and an integral part of the speech pathology team. "To me, the most valuable aspect of interning at Midland is learning how to support students with complex medical needs," says Anita. She, like many of her prede cessors, hopes to one day return to Midland as an employee.

In Occupational Therapy (OT), interns bring a fresh perspective, creative ideas and new resources to the therapy sessions," adds Occupational Therapist, Ms. Suzy Frank. "Having interns gives our students the opportunity to showcase their skills and help teach others. I know I speak for our entire department when I say it is rewarding to have an intern come back as a graduated occupational therapist and tell us how we contributed to their journey."

"Midland is in the business of education and we feel there is no better way to contribute to our field than to be a valuable resource for those training to be educators, therapists, and clinicians," says Principal Massimo. "They are the future."

A Message from the President and CEO

I hope this message finds you and your family in good health.

As we enter this first quarter of 2023, we continue to serve, promote and celebrate the students and adults we support. The past few years have presented our community—and our nation—with multiple layers of challenges; along with those, a sense of unpredictability. Midland is not insulated from any of these challenges. Despite this, we will continue to adapt as we work to support Midland's mission. We are committed to making our plan and...working our plan.

There are several new initiatives underway that I would like to highlight. For example, The Midland School is developing a new Wellness Program, which will emphasize social-emotional learning, self-regulation and responsible decision making. Our Physical Therapy department is looking forward to a new space, ready to accommodate equipment that will be transformative for our students. Likewise, our Occupational Therapy department will also be expanding its space, which will include two individualized treatment rooms. These renovations and upgrades were made possible thanks to the generosity of The Margaret A. Darrin Charitable Trust (read more about this grant on this page).

Midland continues to expand our adult programs and services to support individuals with intellectual and developmental disabilities. In 2022, we opened two new supervised apartments and plan to open additional apartments over the course of 2023. Midland is working together with other entities as part of a public-private partnership to secure rental voucher certificates for each person who moves into an apartment setting.

We have a strong partnership with representatives of Premier Development. This project will be located in Branchburg. We have earmarked a number of first-floor apartments that will be designated for special needs housing. Midland, Premier and Branchburg Township are working collaboratively towards more affordable housing options. If all of the planning comes together, the first of these apartments will be ready by early 2025.

Midland also has other residential projects framed in our fiveyear housing plan, which in reality may lay the framework for the next decade of housing and supports provided by our organization.

Midland is also working with the Branchburg Board of Education and District leadership on the expansion of the space at the Old York School building. In turn, this will be a fundamental component of expanding our Explores Day Habilitation program and Midland's Pre-vocational and Career Planning services. In 2022, Employment Services also added Career Planning to our spectrum of employment supports.

Calendar Year 2023 is off to a good start and clearly is shaping up to be another bustling year at Midland.

Thank you for your vested interest, partnership, and unwavering support of Midland's mission. With your support, we will continue to work our plan.
