Midland Transforms Former Workshop into PT & Wellness Suite

For the past several months, part of The Midland School resembled an episode of Extreme Home Makeover – Midland Edition. Thanks to the generosity of The Margaret A. Darrin Charitable Trust, Affinity Foundation, The Tyler Foundation, and Union Foundation, Midland completely transformed what used to be the woodshop space into a state-of-the-art Wellness Center and Physical Therapy Suite.

The retirement of long-time woodshop teacher, Mr. Anthony Staropoli, coupled with the changing needs of Midland's student population, put this bittersweet plan into motion. "The end of the Midland Workshop and student-made crafts is certainly the end of an era here at Midland," says Midland's President & CEO, Mr. Shawn McInerney, "While we were sad to see this program close, we are excited to turn the page in this new, exciting chapter in Midland's history. It has fulfilled a real need for our students and staff and we are deeply grateful for the charitable partners who helped make this dream project a reality, especially The Margaret A. Darrin Charitable Trust. Their transformational gift that was the catalyst of these changes."

Midland began demolition in 2022 and completed the renovations this summer, just in time for staff training in preparation for the 2023-2024 school year. The new Wellness Center features interactive floor technology that projects images and activities on the floor from the ceiling above. Students can do movement and problem-solving activities such as "rake"

leaves," sort shapes, and play a field sport like soccer, which can be cleaned up with the flick of a switch. Through the connecting doorway, the Physical Therapy Suite is now complete with accessible exercise equipment, mat tables, and a ceiling lift system to safely transfer wheelchair or walker dependent students and help them with gait, balance, standing and walking.

"The lift system has been an absolute game-changer for our department," says Physical Therapy Assistant, Ms. Gloria Argiro. "Physically moving students to the mats can be literally back-breaking. The lift not only makes it easier for us, but safer for the kids, too. Best of all, it has given Midland students the gift of independence and we love seeing their eyes light up when they master a new skill. We are so thankful to have more space and the tools we need to provide the best PT services to our students."

On September 14, Midland hosted a dedication event to reveal the spaces and who made it all possible. Students and staff provided a tour of the new rooms, demonstrated the equipment, and shared personal stories about what it all means to them. Outside the space, a plaque now hangs proudly listing the Foundations and contributors who funded the project, and a few were able to attend and share remarks.

"Affinity is proud to provide support to enable self-sufficiency as well as to empower students at Midland to reach their educational, employment and most importantly, personal goals, says Affinity Foundation, Trustee, Ms. Michelle Jansen.

"While we provided some funding here, the true heroes are the folks that work at Midland," says Executive Director of The Margaret A. Darrin Charitable Trust, Mr. Mike Hanifin. "We were very impressed with the new PT Facility and Wellness Center, which were both well thought out. I know our "investment" in Midland will reap significant benefits for the staff and the kids for years to come."
