

Tax Time Tips



Happy New Year!

The W-2 tax statements for 2024 will be available for viewing and downloading in a PDF format by logging into your ADP portal (Pay & Tax Statements) this month. Paper copies will also be mailed; however, any staff who have opted for paperless tax statements will not receive these forms by mail.

The 1095-C forms are currently being reviewed and will be mailed out to all full-time employees. The 1095-C forms provides health coverage information for you and your covered dependents for tax reporting purposes. Staff are required to report and provide proof of minimum health coverage for your and your covered dependents, if any, on your federal income tax return.

All statements will be available no later than January 31, 2025.

Midland is transitioning the operation of one of our group homes into a medical group home.

The first phase of this transition entailed hiring a Nurse to be the Manager of the home. Midland was fortunate to recruit Ms. Kathy Smith, LPN into this position. Kathy has an extensive history and knowledge of working with adults with intellectual and developmental disabilities.

The second phase of our transition was to staff up the home with additional nurses. Our objective is to have a staff schedule that reflects 12 hours per day of nursing support, seven days per week.

The third phase was to make some temporary modifications to the current group home where these individuals reside. This includes widening doors and installing French doors to accommodate the prompt evacuation of individuals during a fire drill.

The current residence that we are utilizing as a medical group home is a twostory colonial style dwelling, which is not conducive to being a medical group home. The final phase of this project (and perhaps, the most daunting) is locating and purchasing a new home that will serve as our medical group home.

Our objective is to purchase and renovate a large ranch-style home that is fully accessible. This will include but will not be limited to modifying accessible bathrooms, installing a lift-system for changing, ramping along with any other modifications deemed necessary for the operation of a medical group home licensed by the Department of Human Services. Our objective is to have a home that is completely compliant with the Americans with Disabilities Act (ADA) standards.

Consistent with Midland 's core values, our over-arching goal is to support individuals throughout each phase of their life and provide a "Lifetime of Caring." As each person ages and their needs change, we will do all things reasonable and practical to achieve this objective.
